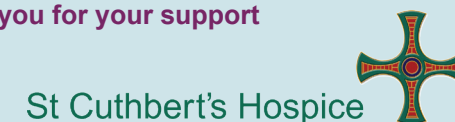
St Cuthbert's Hospice provides free care and support to people with life-limiting illnesses, those approaching the end of life and to families that are bereaved.
